Our suppliers of raw materials and components also have a duty to inform us if their products contain substances on the SVHC candidate list at a concentration above 0.1% w/w. In the event of notification by our suppliers of the existence of one of the substances exceeding the 0.1% w/w threshold, we will inform you as soon as possible, if the products you purchase are impacted. This commitment is valid for any further addition to the Candidate list.

We also confirm that:

- We do not add any of these substances during the manufacturing process.
- We do not manufacture articles which contain substances intended to be released under normal or reasonably foreseeable conditions of use.

Annexes XIV (list of substances subject to authorization) and XVII (restrictions on the manufacture, placing on the market and use of certain dangerous substances, mixtures and articles) of REACH, cover a great number of substances, mixtures and articles affecting many industries.

Suppliers of such substances, preparations and articles have the duty to respect these annexes as far as they are applicable to their products. Aptar Beauty + Home is conscious of its obligations under REACH.
